

WHAT TO DO IN CASE OF FIRE

If you detect a fire:





Modulated alarm signal = evacuation order

- If possible and without taking any risks:
 - Move your vehicle away from the ramp
 - Use the extinguishers or wall hydrants in the vicinity of the ramp doors





- Evacuate: move to the assembly point
- Remain outside the buildings



via the emergency exits



<u>WHAT TO DO IN CASE OF ACCIDENT</u>



- PROTECT the victim in order to avoid further accidents 1.
- 2. NOTIFY the emergency services : fire brigade 18, police 17, ambulance 15
- 3. **ADMINISTER FIRST AID**
- 4. Subsequently, notify a member of the recipient's staff.



WHAT TO DO IN CASE OF A CHEMICAL LEAKAGE/SPILL OF CHEMICALS

For instead an oil tank leaking, damaged barrel containing chemicals (from a previous load)

If the spill is important (hundreds of litters) warn the rescue



- Contain the leak: use absorbent to avoid the spread of the chemical (using protective equipment as advised in the safety sheet)
- Warn a leader from the home site (n° on the next page) who will eliminate the chemical and the soiled absorbent in the right treatment centre

TRANSPORT INSTRUCTIONS

- Access to the site: after positioning himself at the ramp indicated by the depot, the driver leaves the keys to his HGV with the depot management or a team leader / forklift driver in return for a badge
- Only loading/unloading operations advised/planned in advance are permitted
- Vehicles must conform:
 - o to applicable French regulations (technical inspection...)
 - o to the requirements specified in the transport contract
- Products classified as hazardous under the regulations on the transport of hazardous goods (ADR) must not be taken onto the site (even if they remain in the vehicle)
- Nobody is allowed on the ramp or at the rear of the truck during manoeuvring and it's forbidden to maneuver if a pedestrian is close.



- to check the correct positioning at the ramp, the stability and immobilising of the vehicle (blocks and stands)
- o to remain present during loading and unloading
- o to check the correct stowing of the goods on the truck (load stability)
- o to complete the transport documents
- to satisfy himself that the loading or unloading operations have been fully completed before moving off
- to report any anomalies (suspect packages, customs fraud...) as well as any incidents to an employee at the SOLOGIS receiving site
- o to leave the load / unload areas clean
- to have the required documents on board (transport license, truck registration document, insurance certificate...)

THE DRIVER IS RESPONSIBLE FOR HIS LOAD AND FOR HIS VEHICLE

- The driver must not:

- o drive on the site with doors and/or tailboard open
- access the buildings outside of the "reception area for drivers" and the toilets
- o stand in the area used for manoeuvring by forklift trucks
- Ramps must be operated exclusively by SOLOGIS personnel
- Loading/unloading must be carried out exclusively by SOLOGIS personnel
